Regular Meeting November 14, 2024

The Ferndale Borough Council met on Thursday, November 14, 2024, in the Fireman's Recreation Hall at 618 Westinghouse Avenue, Johnstown, PA.

President Owen Hofecker called the meeting to order at 6:00 P.M. Those present recited the Pledge of Allegiance to the U.S. Flag.

## ROLL CALL

#### SEWER/SEWER PROJECT REPORT

Frank DiLoreto was present from EADS.

Seven pressure tests were completed in October.

Station St Walkway Rehabilitation Project: Nancy has sent out the final payment to Straw Construction. The cancelled check needs to be submitted to the DCED. Once completed the project can be closed out and EADS will submit a final invoice.

Rigby Park Improvements Project: JCM anticipates beginning work within the next 2-3 weeks. EADS is working on getting final costs estimated so that a larger portion of reimbursement can be submitted.

Ferndale Ave Sidewalk Rehabilitation Project: The layout of the proposed sidewalk is completed. We need to begin coordination with Camtran about relocating the bus shelter. We are also going to begin work on the PennDOT HOP layout.

Station St Phase 2 Project: Safety review meeting is scheduled for Wednesday, November 27, 2024. PennDOT asked that I invite the local sponsor for the project. Is there anyone who would like to attend the call. The call is on Microsoft Teams, and you can also call over the phone.

DCED LSA 2023 Grant: Received approval to equip the police cruisers with the LPRs. Waiting to receive agreement to receive funding.

DCED Greenways, Trails, and Recreation Program (GTRP): Grant announcement is anticipated for Spring 2025.

DCED LSA 2024 Grant: Funding for the Municipal Building roof is eligible. Received roofing estimate from Blyer Construction. Grant is being prepared for submission.

## TAX COLLECTOR'S REPORT

Tax Collector's Report was presented for October 2024. The amount collected in October was \$1,914.25.

## FINANCE/ACCOUNTS PAYABLE

A motion to pay all Accounts Payable was made by the committee, seconded by Eric Baumbaugh. The motion carried.

A motion to approve the 2025 budget and salary schedule was made by Mark Wissinger Sr seconded by Eric Baumbaugh. A roll call vote was taken with all present members voting yes except for Owen Hofecker he abstained from the vote. The motion carried.

A motion was made by Mark Wissinger Sr to pass Resolution #9 seconded by Eric Baumbaugh. A roll call vote was taken with all present members voting yes. The motion carried.
